



## DEAN'S ORDER NO. 2/2022

### about registering students for **state exams** at the Faculty of Civil Engineering of the University of Žilina in Žilina in the **academic year 2021/2022**

#### Article 1 Introductory provisions

1. The purpose of issuing this order is to establish the procedure and deadlines for registration of bachelor's and master's students in full-time and part-time form for the defense of the final thesis and for the subjects of the state examination at the Faculty of Civil Engineering of the University of Žilina in Žilina (hereinafter referred to as 'FCE UNIZA') in the academic year 2021/2022.

#### Article 2 Registration procedure for students of the Faculty of Civil Engineering of the University of Žilina in Žilina for the state exam in the academic year 2021/2022

1. Pursuant to Article 21 of Directive no. 209 (Study Regulations for the 1st and 2nd degree of university studies at the University of Žilina in Žilina), students of the last nominal years of bachelor's and engineering studies in full-time and part-time form register for state exams at the authorized department guaranteeing their final thesis no later than two months before the start of state exams. In the academic year 2021/2022, state exams will be held at FCE UNIZA from May 24 to 31, 2022.
2. The student registers for the state exams **by March 25, 2022** at the workplace (department) guaranteeing his final thesis in writing, using the form published on the FCE UNIZA website in the section **Students > State exams and final theses**. The application form is listed in Appendix no. 1 of this order.
3. Part of the state examinations in the study programs of FCE UNIZA is in the academic year 2021/2022:
  - a) in bachelor's studies: the subject of the bachelor's thesis and its defense, the compulsory subject of the state exam and the compulsory optional subject of the state exam, in master's studies: the subject is a diploma thesis and its defense and the subject is a professional debate. The subjects of the state exam are graded for credit.
4. The list of subjects of state examinations in the study programs of FCE UNIZA is given in Appendix no. 2 of this order.
5. **The student personally hands over the completed and signed application to the authorized employee of the workplace (department) guaranteeing his final thesis and sends it electronically to the Department of Education of FCE UNIZA.** In the event of an ongoing unfavorable epidemiological situation, students will send the completed and signed application form electronically to the guaranteeing workplace and at the same time to the Department of Education of FCE UNIZA. Registration for the state exam will be closed on **March 25, 2022** at 2 p.m.

#### Article 3 Final provisions

1. The order of the dean of FCE UNIZA becomes valid on the day of signature. It takes effect on the day of publication.
2. The order of the dean of SvF UNIZA no. 2/2021 of February 8, 2021 is cancelled.
